REPORT OF THE REGISTRAR

In 1929, when the construction industry moved to establish the Contractors State License Board, one of the major goals of the Board was public protection. Contractors of that era knew that the key to promoting a healthy construction industry was protecting consumers. Neither that goal nor that belief has changed over the last 70 years.

One protection that has been required of licensed contractors since 1964 is the contractor license bond. In this issue of the *California Licensed Contractor*, there is an informational overview of contractor license bonds. Currently, the license bond amount is \$10,000 for pool contractors and \$7,500 for all other contractors. Do these dollar amounts fit the needs of consumers in 1998?

In a lot of cases, the answer is *no*. In the coming months, the Board will be looking at a plan to stretch a safety net of bond coverage under a project depending on its size and cost. In other words, the safety net will allow for step increases in the bond dollar amount as the project becomes more complex and costly.

On the contractor license bond front, Assembly Bill 771 was recently signed by the Governor. This bill changes the amount for which a consumer may sue a surety company in small claims court. Currently, the small claims court dollar limit is \$5,000 for everyone—except for surety companies. A surety company can be sued for only up to \$2,500; AB 771 will increase the amount to \$4,000, beginning Jan. 1, 2000.

Building Official Donald Schultze Appointed to Contractors Board

Donald L. Schultze, Sacramento County's Chief of Building Inspection, was appointed on February 6, 1998, by Governor Pete Wilson to serve on the Contractors State License Board as a public member/active local building official representative.

Mr. Schultze, who spent many years designing and building bridges in San Diego for CalTrans and in Japan for the Corps of Engineers, continues to build bridges—figuratively—in his roles as a building official and a CSLB Board member.

"The intent of the mission statements for the Contractors Board and for Sacramento County's Building Department are almost identical," Schultze said. "Both organizations share goals of consumer protection and ensuring that construction is performed in a safe manner. Working together, the Board and California's building depart-

ments are able to more effectively meet these goals," he concluded.

Mr. Schultze, a licensed civil engineer, earned a bachelor's degree in physics

from Pacific Lutheran University and a bachelor's degree in civil engineering from the University of Arizona. He has spent 30 years working for building departments in San Diego and Sacramento, as well as time with the State Bridge Department and a stint in the military.

Nationwide Recall Sought of "Omega" Fire Sprinklers

A news release from the U.S. Consumer Product Safety Commission (CPSC) warning consumers about alleged defective "Omega" fire sprinklers produced by Central Sprinkler Corporation was recently mailed to fire protection contractors by CSLB. The CPSC seeks a nationwide recall for repair, replacement or a refund of the "Omega" sprinklers. CPSC staff allege that the sprinklers are defective and are likely to fail in a fire situation. The sprinklers may not properly acti-

vate in the event of a fire, thus exposing the public to bodily injury or death. CPSC is aware of six fires in which Omega sprinklers reportedly failed to operate. In one of these instances, the fire caused more than \$3 million in property damage.

A federal Administrative Law Judge set a trial date for December 14, 1998. The CPSC is hopeful that a settlement can be reached out of court.

Strategic Plan For CSLB

At a special meeting of the Contractors State License Board held in March, Board members voted to approve a new strategic plan for the Board. This plan serves as a compass for the Board until the year 2000 when it will be reviewed and updated. The Board's mission statement remains the same, but the seven goals furthering the Board's mission are new:

1. Licensing of Qualified Contractors.

Ensure that all applicants and licensees are qualified to provide construction.

2. Enforcement. Ensure that unlicensed activity and substandard work or conduct are reduced through proactive and consistent enforcement of the Contractors License Law and Regulations.

3. Consumer Education. Educate consumers to make informed choices about construction services, emphasizing both rights and responsibilities.

4. Contractor Education. Ensure that licensed contractors continually strengthen the technical, management, and services skills required to achieve competent performance.

5. Dispute Resolution. Resolve applicable consumer and contractor disputes quickly and efficiently.

6. Regulatory Streamlining. Ensure that all statutes and regulations are necessary, easily understandable, and equitable to consumers and contractors.

7. Organizational Efficiency. Increase organizational efficiency and cost-effectiveness.

Mission Statement

The Contractors State License Board shall protect consumers by regulating the construction industry through policies that promote the health, safety, and general welfare of the public in matters relating to construction. The Contractors State License Board will accomplish this by:

- Ensuring that construction is performed in a safe, competent, and professional manner through licensing of contractors and enforcement of the licensing laws.
- Providing resolution to disputes that arise from construction activities.
- Educating consumers so that they may make informed choices.

BOARD BRIEFS

Classification Restructuring

Licensing Committee Co-Chairs Robert Alvarado and Nina Tate have forwarded the consolidation of a number of licensing classifications in the last year. Here is a summary of recent restructuring of license classifications:

C-6 Cabinet and Millwork and C-5 Carpentry. C-6 Cabinet and Millwork was merged into C-5 Carpentry effective January 1, 1998. Implementation will be effective once revisions to the C-5 examination are complete.

C-26 Lathing and C-35 Plastering. C-26 Lathing was merged into C-35 Plastering effective January 1, 1998. Implementation will be effective once revisions to the C-35 examination are complete.

C-14 Metal Roofing, C-43 Sheet Metal, and C-39 Roofing. C-14 Metal Roofing was merged into C-43 Sheet Metal or C-39 Roofing effective July 1, 1998. An implementation plan is being developed.

C-51 Structural Steel. The Board voted to clarify that "metal roofing systems" can be installed as part of a C-51 project. The proposed clarification will go the Department of

Consumer Affairs, then to the Office of Administrative Law for review and approval.

Those who **currently** hold any of these classifications will not be required to take an examination or change classifications. **New** applicants will be required to take a newly-developed examination.

Free Payroll Tax Seminars

EDD To Contractors: Don't Be Taken By Surprise

The Employment Development Department (EDD) offers educational payroll tax seminars at no charge to you. At these seminars, contractors learn how to determine when workers, day laborers, and subcontractors are actually employees and when they are legally independent contractors. These seminars may help you avoid unplanned payroll tax liabilities.

Under California law, a contractor (licensed or unlicensed) who engages the services of unlicensed subcontractors or construction workers is, by specific statute, the employer of those unlicensed subcontractors or workers, even if the subcontractors or workers are believed to be independent contractors.

The bottom line is that without a valid contractor's license, a person (day laborer, subcontractor, etc.) performing services in the construction trade is an employee of the contractor who either holds a license or is required to be licensed.

The term "valid license" means the license was issued to the correct individual or entity, the license was for the type of service being provided, and the license was for the entire period of the job.

Caution: Possession of a valid contractor's license does not automatically make the worker an independent contractor. The worker must also be performing services under conditions and circumstances which would support an independent contractor relationship under Section 2750.5 of the Labor Code and the usual common law rules.

1998 Cost Index for Type B Construction

Government Code Section 66452.6(a) establishes that an approved or conditionally approved local subdivision map shall expire 24 months after its approval or conditional approval (local ordinances may add up to 12 months to this 24-month period).

Within the law, however, there is a provision for extending the life of the map for 36 months beyond the date of its expiration (or beyond the date of the previously filed final map, whichever is later), if the subdivider is required to spend \$125,000 or more for public improvements outside the property boundaries of the tentative map.

(Public improvements here include traffic controls, streets, roads, high-

ways, freeways, bridges, overcrossings, street interchanges, flood control or storm drain facilities, sewer facilities, water facilities, and lighting facilities.)

The law authorizes an annual change to this \$125,000 expenditure limit based on an adjustment for inflation set forth in the statewide cost index for class B construction determined by the State Office of Local Assistance at its January meeting.

The cost index determined by the State Allocation Board at its January 1998 meeting was 1.29. Therefore, the limit effective March 1, 1998, is \$161,250. Developers with questions concerning this subject should contact their local planning departments for assistance.



Bond Basics: A Brief Discussion About Bonds

There are five kinds of construction bonds: performance bonds, payment bonds, and contractor license bonds. The type discussed here is the mandatory contractor license bond. All contractors are required to maintain a form of security deposit as a guarantee that they will perform in a good and workmanlike manner. Contractor license bonds are commonly used for this purpose.

Before an active contractor's license can be issued or renewed, or a previously inactive license made active, the licensee must have a contractor license bond, or an approved alternative to the bond, on file with the CSLB. The license bond must be in the amount of \$10,000 for swimming pool contractors and \$7,500 for all other classifications.

In addition, contractors must have a \$7,500 bond of qualifying individual, or an approved alternative to the bond, on file for each responsible managing employee (RME). Also a \$7,500 bond of qualifying individual must be on file for each responsible managing officer (RMO), unless the RMO owns 10 percent or more of the voting stock of the corporation.

A bond may be issued for whatever length of time the contractor and insurance agent or bond company arrange. Most bonds are issued for one to three years. At the end of that time, the bond may be canceled, or the bond company may request another premium to extend the life of the bond.

Instead of filing a license bond with the CSLB, a contractor may use one of the following approved alternatives for filing a security deposit: certificate of deposit; bank savings account, savings and loan investment certificate, or share account; credit union certificate for fund or share account; cash; or bearer bonds.

A license bond should not be confused with an insurance policy. A major difference between an insurance policy and a license bond is that contractors remain primarily liable for their obligation under a bond and must repay the

surety company if the company pays out on a claim. Additionally, a license bond is for the benefit of the public and does not necessarily protect the contractor from liability.

Disciplinary Bonds

If a license has been revoked—or in some instances, suspended—for a violation of contractors license law, the contractor must file a disciplinary bond with the Registrar to reinstate, reissue or reapply for a new license.

The amount of a disciplinary bond may not be for less than \$15,000 or greater than 10 times the contractor license bond, and it must be on file with CSLB for at least two years.

Filing a Bond Claim

A contractor has an obligation not to commit any violation of contractor license law that is grounds for disciplinary action against the license. If the contractor does not comply with the conditions of the bond, a claim can be filed with the surety company.

Claims against a surety company may be filed by homeowners, any person damaged by a willful and deliberate violation of a construction contract, employees damaged by the contractor's failure to pay wages, or an express fund damaged as a result of the contractor's failure to pay fringe benefits for eligible employees. (A court case has held the express trust fund provision superceded by federal law.)

Consumers must file surety bond claims with the surety company that wrote the bond within specified time frames. The CSLB does not process claims against surety companies. Surety companies will investigate any claim filed against a bond, and the CSLB will investigate any complaint filed against the license.

A license bond is canceled 30 days from the date that CSLB receives a cancellation notice from a bond company. If a bond reinstatement notice is **not** received by CSLB or a replacement bond is **not** received by CSLB before the end of the 30-day period, the license is suspended.


Bond "Checkup"

Contractors are encouraged to perform a bond "checkup" by verifying on the Automated Phone Response System or on the Internet that your bond is current. Most bond renewals and license renewals are not on the same cycle, so do not assume that when your license renews your bond also renews.

Renew promptly: Avoid a license suspension by renewing your bond promptly and making sure the effective date of the new bond is the same as the cancellation date of the old bond. Allow for processing time by arranging for a new bond four weeks before the old one expires.

Who files: Ask your bond agent if the surety company will file the bond with CSLB or if you must file it. If you hold the original bond, send it in to CSLB. The CSLB does not return any bond that has been accepted or processed as the bond of record on an active license.

Keep records: Keep accurate records on your agent, surety company, bond numbers, effective dates, and terms of the bond.

Integrated Waste Management Board Urges Contractors to Reduce Construction and Demolition Debris

The California Integrated Waste Management Board (CIWMB) urges contractors to reduce construction and demolition debris by recycling and reusing materials from construction job sites. Currently, an estimated 20-30 percent of the state's waste stream is from construction and demolition debris.

Information—including publications, a series of fact sheets, and a website—is available from the CIWMB to provide details on recycling at the job site and how it can save you money. The "Construction and Demolition Recycling Program" fact sheet summarizes CIWMB programs. The fact sheet lists available materials, including "Asphalt Pavement Recycling," "Drywall Recycling," "Recycled Latex Paint," and "Why Use Recycled Plastic Lumber?"


The Big One That Did Not Get Away

Although the Contractors State License Board repeats the "hire only licensed contractor" mantra over and over to homeowners, we receive thousands of complaints against nonlicensees every year. It's frustrating for Board investigators to receive a complaint in which the unlicensed operator takes off, leaving no trace of his or her whereabouts and no recourse for the homeowner. However, sometimes the good guys win.

Recently, the CSLB San Francisco District Office received a complaint from a San Mateo homeowner who hired an unlicensed contractor to repair her home after it had been severely damaged in a fire. The nonlicensee solicited the homeowner and won her confidence because he lived in the neighborhood and had attended school with her son. Additionally, he illegally used a licensed contractor's number.

The contract amount was a whopping \$99,562. After receiving \$96,300, and

performing less than \$60,000 worth of work, he abandoned the project. The guy must have been too busy talking to complete the job because he also used the homeowner's phone without her permission to rack up a \$2,074 phone bill for calls to Tonga!



After the CSLB investigator waded through a stack of 26 exhibits, which resulted in a 14-page report, the Board submitted the case to the San Mateo District Attorney's Office, requesting a criminal prosecution for felony and misdemeanor violations. The preliminary hearing was held on June 25, 1998, and the unlicensed contractor was bound over for arraignment in Superior Court. He is out on \$50,000 bail.

As it turns out, the nonlicensee is not only a con artist but is up on separate drug, phone fraud cloning, and petty theft charges in San Mateo.

FAQs* About Home Improvement Certification

All licensed contractors engaged in home improvement work will be required, beginning January 1, 1999, to take an open-book examination and be certified to continue this type of work. Contractors will have until July 1, 2000, to obtain the certification.

Contractors License Law defines "home improvement" as: "[T]he repairing, remodeling, altering, converting, or modernizing of, or adding to, residential property and shall include, but not be limited to, the construction, erection, replacement, or improvement of driveways, swimming pools, including spas and hot tubs, terraces, patio awnings, storm windows, landscaping, fences, porches, garages . . . and other improvements of the structures of land which is adjacent to a dwelling house."

At right are frequently asked questions* from you on this topic.

- Q.** How did Home Improvement Certification come about?
A. The certification requirement was the result of Assembly Bill 1213, signed into law by Governor Wilson in 1997.
- Q.** When will contractors take the examination?
A. Contractors can take the examination beginning January 1, 1999, and must take the exam and be certified by July 1, 2000. The CSLB encourages contractors to take the examination as soon after January 1, 1999, as possible.
- Q.** How will contractors take the examination?
A. The CSLB is looking at different ways contractors may take the examination, including pen and paper, over CSLB's Automated Phone Response System, or on the Internet. The CSLB will make every effort to provide the application and examination to contractors with a minimum amount of disruption to their daily business.
- Q.** Will there be a fee?
A. No fee will be charged for Home Improvement Certification.
- Q.** Can contractors get the examination application and information now?
A. A study guide, application, and examination are being developed now. Information will be distributed to contractors before January 1, 1999.
- Q.** Do B-General Building Contractors have to take the examination?
A. Yes, all contractors engaged in home improvement work, including swimming pool contractors, will be required to obtain the Home Improvement Certification. The Home Improvement Certification is intended to be a useful and educational tool for licensed contractors and should not be considered an additional license classification.
- Q.** What if a home improvement contractor does not become certified by July 1, 2000?
A. The contractor would be in violation of Contractors License Law and subject to discipline by the CSLB.

Home Sweet Home Improvement Certification



In the last issue of the *California Licensed Contractor*, you were asked to answer a survey about the home improvement certification program and examination.

Thousands of you responded — 4,880 to be exact — and we found out that 95.5 percent of licensed contractors have done some type of home improvement work, and 95.6 percent plan to become certified and work in the home improvement arena.

Survey questions were included to determine the best ways to administer the open book examination. Fewer than half of the respondents — 44.8 percent — said they have access to the Internet, and 11.9 percent stated they would prefer to take the examination on the Internet. Most — 85.8 percent — said they prefer to take the examination at their office or home and mail in the answer sheet.
