Report of the Registrar

Construction and contracting are booming in California—at last! Reports from the field are that many contractors have more work than they can handle. Some of you have to turn away work; others have figured how to do more, more efficiently, to keep up with demand.

The Contractors State License Board finds itself in a similar situation. We are not only in a position of evaluating how to conduct the business of licensing and regulating contractors because of an increased load, but we also have an obligation to our contractor and consumer clients to do our job more efficiently.

A re-engineering pilot project, currently being conducted in Southern California, addresses the issues of efficiency and service. We are consolidating several district offices into one center where work coming into the Board can be prioritized and dealt with quickly and consistently, putting more CSLB deputies in the field working on investigations. The end result, we believe, will be more work being done, more quickly, more accurately, and more economically. The project will continue through Summer 1999 and then be evaluated.

70th Anniversary: Then 'N' Now



The Contractors State License Board is nearing its 70th anniversary. At its June 1999 meeting, the Board will recognize contributions building contractors have made to California.

On June 13, 1929, state lawmakers sent to the Governor legislation that required registration of contractors. Not surprisingly, over the course of seven decades, California has seen an increase in the number of licensed contractors.

It was not until the late 1940s that CSLB defined classifications of specialty subcontractors. Previously, contractors simply marked a box on their application declaring themselves a specialty subcontractor.

Home Improvement Certification Underway

Congratulations to the more than 2,000 contractors and qualifiers who have taken and passed the new Home Improvement Certification examination on the CSLB website. CSLB staff encourages contractors to study for and take the test on the Internet for instant results and speedy certification. However, for those who prefer taking their exams the traditional way (including sweaty palms?), a copy of the study guide, application and exam will be mailed automatically to all current and active contractors by the end of June 1999. The certification is in addition to the regular contractors license, and there is *no fee* to take the examination.

All contractors, whether acting as a prime or subcontractor, who perform

any kind of home improvement work on residences, including those who sell home improvement goods and services, must pass an examination and be certified by the CSLB no later than July 1, 2000.

Board Briefs

Following are the highlights of the February 25, 1999, Contractors State License Board Committee meetings held in Pomona.

Licensing Committee

As a result of streamlining, license renewals are being processed as they come in the door. Processing of exam applications is down to 3 1/2 weeks, and processing of waiver applications is down to 4 1/2 to 5 weeks. Licensing staff is using online National Association of State Contractors Licensing Agencies revocation information from other states to process applications.

With input from licensing schools and industry groups, CSLB is reviewing and redesigning the original license application for the purposes of simplifying the form and reducing processing time.

A presentation was given about CSLB's current interpretation of laws and regulations concerning an applicant's criminal conviction.

CSLB Pilot Project Up and Flying

A pilot project to reorganize the Contractors State License Board operations got underway on March 1, 1999, with approval of the full Board. The pilot, presently being conducted in Los Angeles, Orange, San Bernardino, and Riverside counties, is to test the effectiveness of centralizing public contact and mediation services. CSLB believes that new procedures will speed up the complaint process. All public contact and mediation services staff is being housed in Buena Park.

Currently, the Van Nuys District Office is closed, and the Inglewood Office is open in the morning on Monday, Wednesday, and Friday only. As of July 1, 1999, the Moreno Valley and Santa Ana District Offices will be closed. Contact CSLB in the four-county area at P.O. The pilot project will be evaluated in the fall of 1999.

Executive Committee

A CSLB staff re-engineering pilot project would get underway in the four-county Los Angeles region on March 1, 1999, by reassigning staff from the Inglewood, Van Nuys and Azusa offices to a new Intake and Mediation Center in Buena Park. The full Board unanimously authorized implementation of the project at its January 26, 1999, meeting. Read more about this pilot project below.

Governor Davis' Executive Order that halts new non-Year 2000 computer projects and creates a Year 2000 Executive Committee was reviewed. CSLB is Year 2000 compliant and does not expect any interruption in service to contractors and consumers.

Legislation Committee

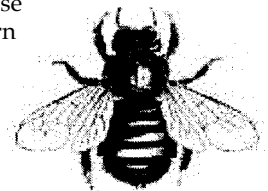
A number of legislative bills were discussed and Committee positions decided, including ACA 5 (Assemblymember Honda), a proposed amendment to the State Constitution that would prohibit mechanics' liens on single family owner-occupied dwellings. The Committee recommended a watch position on ACA 5, and the Board adopted the watch position.

CSLB developed legislative counsel language on all measures that were approved by the Board at the December 9, 1998, Board meeting.

CSLB Seeks Property for Stings

From time to time we report on CSLB stings of unlicensed contractors. These undercover stings cannot take place without a property at which to hold them.

Judgment and Arbitration Awards

Contractors who ignore or underestimate the effect of a construction-related judgment may find their license suspended. A judgment against a contractor can come from a civil court decision, an arbitration award, or a liability levied by another government agency. The Department of Industrial Relations, Employment Development Department, and Franchise Tax Board liabilities include taxes, tax additions, penalties, and interest.



Last fiscal year, the CSLB received 3,447 judgments against contractors totalling \$33,585,942 and 455 outstanding liabilities in the amount of \$20,933,562.

Any party to a judgment can notify the CSLB of the decision; however, a contractor has a legal obligation to notify the CSLB of any such outcome. For example, if a contractor is taken to civil court by a consumer over a home improvement dispute and ordered to pay a monetary judgment, the consumer may notify the CSLB of the decision, but the contractor is required to do so.

When contractors receive construction-related judgments against them, here is what happens:

- The contractor must mail into the CSLB the decision within 90 days of the judgment.
- When that occurs, the contractor is given an additional 90 days to resolve the judgment.
- If the judgment is not resolved, the license is suspended until the judgment is resolved.
- If the CSLB is not notified within 90 days, the contractor's license is suspended upon notification.
- If the license is suspended, the contractor and/or qualifier cannot contract.
- Additionally, contractors and qualifiers are automatically prohibited from using any other contractor's license to contract.
- Any other license on which that contractor is named is suspended

until the judgment is resolved or until that contractor disassociates from the other license.

Judgments mailed into CSLB must be related to the contracting business in any way. The law states that a judgment must be "substantially related to the construction activities of a licensee . . . or to the qualifications, functions or duties of the license."

Contractors can satisfy a judgment in a number of ways by mailing to the CSLB one of the following:

- A copy of a properly executed "Acknowledgment of Satisfaction of Judgment" form signed by the judgment creditor and filed with the court.
- Copies of a canceled check (front and back) for the full amount.
- Copy of a bankruptcy filing with the page of creditors that lists the appropriate judgment creditor.
- A properly executed agreement between the parties setting up a payment schedule, signed by both parties.
- A properly executed judgment bond.

Try to resolve judgments, and do not wait until the last few days before the suspension occurs. It is often difficult to get all of the acceptable paperwork in order at the last minute. Home Improvement Protection Plan

The Contractors State License Board has begun exploring a number of issues related to strengthening consumer protection and reinforcing the position of hardworking, honest contractors in the home improvement arena.

"CSLB has identified homeowners who contract for home improvement work as the consumers most vulnerable to incompetent or untrustworthy contractors. The average homeowner

lacks the knowledge and sophistication to determine if a contractor has both the technical skill and the fiscal expertise to adequately perform," said Registrar Dr. C. Lance Barnett.

Two topics being examined are home improvement bonds and general liability insurance. A roundtable of industry, consumer groups, and CSLB staff was held in January to discuss the pros and cons of general liability insurance for contractors.

News from Other Agencies



Office of the State Fire Marshal

The State Fire Marshal has determined that a fire sprinkler system utilizing recalled Omega fire sprinkler heads is deficient and cannot pass the quarterly maintenance inspection or five-year certification test. Any fire sprinkler system containing a recalled Omega sprinkler heads cannot be certified at the five-year test. In the meantime, the State Fire Marshal strongly recommends the replacement of all affected Omega fire sprinkler heads as soon as they are identified.

The Summer 1998 issue of the *California Licensed Contractor* reported the recall of these sprinklers because they are defective and are likely to fail in a fire situation.

Public Works Arbitration Committee

The Public Works Arbitration Committee has shortened the time from 180 days to 90 days in which a claimant in a public works contract can initiate arbitration. This new provision, effective January 1, 1999, is a result of AB 2084 and applies only to contracts entered into on or after January 1, 1999.

California Building Standards Commission/ International Conference of Building Officials

The California Building Standards Commission has updated all 11 parts of the California Code of Regulations, most of which become effective July 1, 1999. Title 24 of the California Code of Regulations is now available through the ICBO by calling (800) 284-4406, (562) 699-0541 or by visiting the ICBO Product Store online at www.ibco.org.

The California Codes and corresponding Uniform Codes are fully integrated to create a complete package and include a three-year subscription service for all state updates and supplements. For anyone who has already purchased a Uniform Building, Fire or Mechanical Code, California amendment packages and subscription services can be purchased separately.

State Allocation Board

Government Code Section 66452.6(a) establishes that an approved or conditionally approved local subdivision map shall expire 24 months after its approval or conditional approval (local ordinances may add up to 12 months to this 24-month period).

Within the law, however, there is a provision for extending the life of the map for 36 months beyond the date of its expiration (or beyond the date of the previously filed final map, whichever is later), if the subdivider is required to spend \$125,000 (adjusted to the cost index which in 1999 is \$125,000 multiplied by 1.31) or more for public improvements outside the property boundaries of the tentative map. (Public improvements here include traffic controls, streets, roads, highways, freeways, bridges, overcrossings, street interchanges, flood control or storm drain facilities, sewer facilities, water facilities, and lighting facilities.)

The law authorizes an annual change to this \$125,000 expenditure limit based on an adjustment for inflation set forth in the statewide cost index for class B construction determined by the State Office of Local Assistance at its January meeting.

The cost index determined by the State Allocation Board at its January 1999 meeting was 1.31. Therefore, the limit effective March 1, 1999, is \$163,750. Developments with questions concerning this subject should contact their local planning departments for assistance.

CSLB Y2K Status

The Contractors State License Board is in the process of completing Year 2000 (Y2K) compliance requirements. Our data files and computer hardware are fully compliant. We estimate our computer software will be fully compliant by fall 1999. The CSLB is taking every precaution possible, including extensive testing, to assure uninterrupted service for our clients. Although we cannot guarantee the compliance of our external business partners, we do not anticipate Y2K-related problems.

Contractor License Law defines "home improvement" as: "(T)he repairing, remodeling, altering, converting, or modernizing of, or adding to, residential property and shall include, but not be limited to, the construction, erection, replacement, or improvement of driveways, swimming pools, including spas and hot tubs, terraces,

patio awnings, storm windows, landscaping, fences, porches, garages . . . and other improvements of the structures of land which is adjacent to a dwelling house."

Contractors will receive a new pocket license bearing an "HIC" designation, and CSLB public information (toll-free phone system and the website) will include certification information.

The first contractor passed and became certified on January 27, 1999. Since then, more than 2,250 have followed. On the average, it is taking four tries to pass the exam; CSLB staff suggests that contractors take the time to review the study guide before tackling the exam.

Fee Credit To End

Since July 1, 1997, some license renewal fees reflected a \$100 credit, making the fee for timely active license renewal and license reactivation fee only \$200, instead of the usual \$300. That \$100 credit will end July 1, 1999, and the renewal and reactivation fees will go back to \$300.

If your license is due for renewal before July 1, 1999, get your application and fee into the CSLB. Renewals will be subject to the \$300 fee if the application is postmarked on or after July 1, 1999, even if the form shows the old fee. If a renewal application is returned to you for corrections and an acceptable renewal is not returned to the Board postmarked on or before July 1, 1999, you will be required to submit the increased fee.

CSLB was required to reduce the amount of fees collected in order to reduce the Board's reserve fund.

- C-51 (Structural Steel);
- C-55 (Water Conditioning);
- C-57 (Well Drilling—water); and
- C-60 (Welding).

Interested contractors must meet minimum qualifications and attend a CSLB training session to become an Industry Expert. Qualified and trained Industry Experts use their expertise to render an official opinion that can be used by CSLB staff after a complaint is filed with the Board. The opinion becomes part of the decision making process regarding whether or not a violation of the law has occurred.
