Five Charged with Felony Unlicensed Contracting in Eaton Fire Disaster Area

Five individuals have been charged with felony unlicensed contracting in a declared disaster area following an enforcement operation in Altadena.

CSLB's Southern Statewide Investigative Fraud Team (SWIFT) partnered with the Los Angeles County District Attorney's Office on the operation that targeted individuals suspected of unlicensed contracting in neighborhoods affected by the January Eaton Fire, which is a declared disaster area. State law makes it a felony to contract without a license in a declared disaster area. Violators face up to three years imprisonment and/or a fine of up to \$10,000.

During the operation, the individuals provided bids in the tens of thousands of dollars for rebuilding in Altadena. Any construction work valued at \$1,000 or more, including labor and materials, requires a valid California contractor license. Anyone contracting in a declared disaster area should also be aware that all reconstruction must comply with home improvement contract consumer protections, which means that the work needs to follow payment restrictions. Contractors cannot ask for more than \$1,000 for a down payment and additional payments cannot exceed the value of work performed.

"CSLB is committed to its consumer protection mission as wildfire survivors recover and rebuild. Combatting unscrupulous contractors, protecting the public and empowering survivors with resources as they navigate the process," said Registrar David Fogt. "We encourage consumers to visit CSLB's [Disaster Help Center](#) as their resource to verify a license or to file a complaint."



"These arrests send a warning to criminal contractors that they will be prosecuted for preying on the thousands of Los Angeles County residents who lost their homes in the January wildfires," Los Angeles County District Attorney Nathan J. Hochman said. "It is a felony to target wildfire victims at their most vulnerable and contract without a license in a disaster zone. We urge residents rebuilding their homes to report unlicensed contractors who are taking advantage of this disaster. Together with our partners at the California Contractors State License Board, we are holding unlicensed contractors accountable and protecting victims from exploitation and further harm."

CSLB Expands Outreach to Promote Hiring Licensed Contractors

Over the past year, the Contractors State License Board (CSLB) has significantly expanded its outreach efforts to educate Californians, especially vulnerable people, on the importance of hiring licensed contractors and understanding their rights when it comes to construction and home improvement services.

SENIOR SCAM STOPPERSM PROGRAM: PROTECTING OLDER CALIFORNIANS



CSLB's Senior Scam StopperSM program is key to outreach efforts. In partnership with state legislators and other community partners, CSLB's outreach

coordinator travels across California to present vital information to seniors about:

- Common construction-related scams
- How to verify a contractor's license using CSLB's website
- How to file a complaint or report unlicensed activity
- What to look for in a legitimate contractor advertisement
- What the rules are regarding down payments and progress payments
- How to protect themselves from door-to-door solicitation fraud

These events give seniors the tools they need to make informed decisions and avoid becoming victims of fraud. CSLB also hosts Consumer Scam StopperSM seminars for the general public that touches upon many of the same topics, intended for people of all ages.

In the past year, CSLB hosted 52 Senior Scam StopperSM seminars with local and state officials and with panelists from the Bureau of Household Goods and Services, Department of Insurance, Department of Real Estate, the Department of Financial Protection and Innovation, the Department of Justice, and California Privacy Protection Agency, among various local partners.

DISASTER RECOVERY OUTREACH: REBUILDING SAFELY AND LEGALLY

In response to recent Los Angeles County wildfires, CSLB partnered with Los Angeles County Public Works and Catholic Charities to host Rebuilding After a Disaster workshops this fall. They are designed to help disaster survivors rebuild safely and confidentially by providing guidance on:

- How to find and hire only licensed contractors
- Understanding advertising laws and contractor identification requirements
- Navigating CSLB's website to verify licenses and request materials

- The down payment rule (no more than 10% or \$1,000, whichever is less)
- Setting up lawful progress payment schedules
- Verifying workers' compensation insurance
- Screening door-to-door salespersons and avoiding high-pressure tactics

These workshops play a critical role in CSLB's mission to protect consumers after disasters and ensure rebuilding is handled by qualified, licensed professionals.

ENFORCEMENT IN ACTION: SWIFT OPERATIONS TARGET UNLICENSED ACTIVITY

CSLB's Statewide Investigative Fraud Team (SWIFT) continues conducting sting operations and jobsite sweeps across California to identify and take action against unlicensed contractors. These enforcement efforts protect consumers and ensure a level playing field for licensed professionals.

In addition, CSLB recently announced a collaboration with the National Association of State Contractors Licensing Agencies (NASCLA) to strengthen enforcement and share best practices across state lines. This partnership enhances CSLB's ability to track and stop unlicensed individuals who operate across multiple jurisdictions and reinforces the importance of contractor licensing nationwide. LICENSED CONTRACTOR BENEFIT

As a licensed contractor, you are part of the solution. CSLB's outreach efforts not only protect consumers, but they also support your business by promoting a fair and legal marketplace. HOT TOPICS

New Laws Affecting Contractors Starting in 2026

Contractors should be aware of new state laws taking effect on January 1, 2026, that may impact their business operations, contracts, and licensing. These changes, passed during the 2025 legislative session, aim to strengthen consumer protections, improve enforcement, and clarify responsibilities across the construction industry.

AB 521 (Carrillo) – This bill clarifies that CSLB is not liable for attorney fees in civil claims involving a contractor's cash deposit filed in lieu of a license bond. This change helps define CSLB's role in such disputes and limits its financial exposure.

AB 1002 (Gabriel) – The Attorney General (AG) and CSLB are now jointly authorized to bring civil actions to suspend, revoke, or deny a contractor's license for failing to pay workers or comply with a wage judgment or court order. The AG must notify CSLB before initiating such action, and CSLB may choose to intervene or collaborate in the proceedings.

AB 1327 (Aguiar-Curry) – Contractors working in the home improvement sector must now include their email address in home improvement contracts and allow buyers to cancel via email. Contracts must also include a telephone number to help buyers locate and complete the "Notice of Cancellation." If this notice is missing, consumers may file a complaint with CSLB.

SB 291 (Grayson) – This bill significantly increases penalties for workers' compensation (WC) insurance violations. The Board must also develop a new process to verify WC exemption eligibility and report findings to the Legislature by 2027. Annual reporting of WC enforcement data is also now required. Additional information on WC requirements can be found [here](#).

SB 456 (Ashby) – A new exemption from licensure has been created for muralists. Individuals who paint or restore murals under agreement with a legally authorized party are no longer required to hold a contractor license, provided the mural is a unique work of fine art painted by hand directly on an interior or exterior wall or ceiling, and protected by copyright or similar rights. This exemption does not apply to painted wall signs.

SB 517 (Niello) – Contractors using subcontractors in home improvement projects must now disclose that information upon request. This includes the subcontractor's name, contact information, license number, and classification. While the prime contractor remains responsible for the overall project, subcontractors and home improvement salespersons may also face disciplinary action for violations.

SB 779 (Archuleta) – Beginning July 1, 2026, CSLB will increase minimum civil penalties for certain violations. Fines for unlicensed activity will start at \$1,500, and other specified violations will carry minimum penalties of \$500 or \$1,500, depending on the offense. These amounts will be adjusted every five years based on the Consumer Price Index.

Leveling the Playing Field: CSLB Targets Unlicensed Contractors in Nationwide Enforcement Effort

As part of a national crackdown on unlicensed contracting, CSLB recently completed a major enforcement effort resulting in 119 legal actions across California. The operation was part of a multi-agency effort led by the National Association of State Contractors Licensing Agencies (NASCLA) and reinforces CSLB's commitment to protecting both consumers and licensed professionals.

PROTECTING YOUR LICENSE AND YOUR LIVELIHOOD

Unlicensed contractors undercut legitimate businesses, skirt safety regulations, and put consumers at risk. That's why the Statewide Investigative Fraud Team (SWIFT) takes action against those who operate outside the law.

OVER A TWO-WEEK PERIOD, CSLB CONDUCTED:

- **3 undercover sting operations** in San Joaquin, Kern, and San Diego counties
- **46 jobsite sweeps** in 17 counties, with 454 site visits

These efforts uncovered widespread violations, including illegal advertising, excessive down payments, and unlicensed bids on projects ranging from \$1,000 to \$46,000, well beyond the legal threshold for unlicensed work.

ENFORCEMENT BY NUMBERS



Several individuals also violated California's down payment law, which limits payments to 10 percent of the contract price or \$1,000, whichever is less.

A NATIONAL EFFORT WITH LOCAL IMPACT

"Nationwide enforcement operations such as the NASCLA coordinated enforcement effort are vital in educating consumers about the risks of not checking a contractor's license and deterring unlicensed or unqualified practice," said CSLB Registrar David Fogt.

Women in Construction Conference Inspires the Next Generation

The 2025 Women in Construction Conference drew a record-breaking crowd of more than 2,100 attendees, including hundreds of high school students who attended for free.

Sacramento Regional Builders Exchange (SRBX) and Construction Industry Education Foundation (CIEF) held the event October 15-16 in Sacramento. The first day began at the Crest Theatre with a panel discussion featuring accomplished

women from across the industry, including construction industry panelists from Swinerton and Skanska USA Building Inc. Yachting Industry Captain Sandy Yawn shared a keynote address of her story of leadership and perseverance in a male-dominated field.

On the second day, the conference moved to the SAFE Credit Union Convention Center, where a ballroom full of vendors offered apprenticeship opportunities, career pathways, and hands-

on demonstrations. Attendees participated in sessions focused on leadership, communication, and personal growth, and heard from State Controller Malia Cohen and other speakers.

Many participants emphasized that mentorship and representation are vital to helping women gain confidence and advance in their careers. When women see others thriving in leadership positions, it broadens their understanding of what is possible and helps build

pathways for the next generation to follow. Events like this serve as an important reminder of the power of community and collaboration in expanding opportunities across the trades.

California's commitment to this effort is evident through major state investments, including \$26 million in [ERiCA \(Equal Representation in Construction Apprenticeship\) grants](#) and an additional \$13 million dedicated to fostering career pathways for

women in construction. These initiatives support childcare assistance, targeted recruitment, and inclusive worksite culture programs—paving the way for more women to enter and thrive in the trades. As California expands its housing and infrastructure projects, this momentum, combined with events like the Women in Construction Conference, helps build a stronger, more innovative, and inclusive construction workforce.

Contractors Can Support the Future of Construction Management Education

The [Construction Management Education Account \(CMEA\)](#) plays a vital role in shaping the future of California's construction workforce. CMEA provides financial assistance to state university programs that prepare students to become the next generation of licensed contractors, project managers, and industry leaders.

In 2024, CSLB awarded \$225,000 in CMEA grants to construction management

programs within the California State University system. The Board reviews the grant awards at each December quarterly meeting. These funds helped expand hands-on training opportunities, enhance classroom resources, and support curriculum development focused on construction safety, leadership, and sustainability. By investing in education, CMEA helps build a skilled, knowledgeable, and ethical construction workforce for California's future.

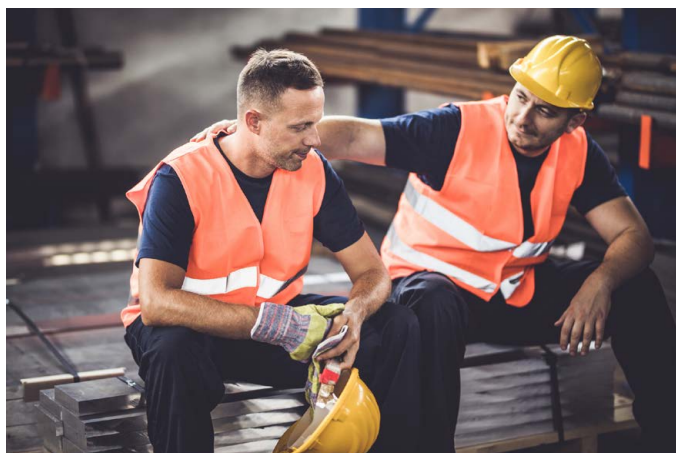
Breaking the Silence: Promoting Mental Health in Construction

The construction industry helps power California's growth but also faces one of the nation's most serious mental health challenges.

According to the [Centers for Disease Control and Prevention \(CDC\)](#), construction remains among the highest risk industries for suicide. In 2021, suicide rates reached 56 per 100,000 men and 10.4 per 100,000 women working in construction, higher than most other occupations.

Substance and alcohol misuse are also more common among construction workers than in the general workforce. Data from the [Substance Abuse and Mental Health Services Administration \(SAMHSA\)](#) show 16.5 percent of construction workers reported heavy alcohol use in the past month, compared to 8.7 percent of all full-time workers across industries. In addition, 14.3 percent of construction workers say they abused substances in the past year. These statistics highlight the need for awareness, support, and lasting cultural change within the industry.

The CDC, along with the [Center for Construction Research and Training](#), identified several key factors contributing to this problem:



- 1. Job strain and low control.** High physical and mental demands, limited autonomy, and inconsistent employment can increase stress and suicide risk.
- 2. Long hours and overtime culture.** Persistent financial and scheduling pressures can lead to burnout and fatigue.
- 3. Access to lethal means.** Work and home environments where firearms or medications are easily accessible increase risk.
- 4. Injury, chronic pain, and opioid exposure.** Pain management and opioid use often overlap with higher rates of overdose and suicide.
- 5. Cultural stigma.** A male-dominated culture that values toughness and discourages seeking help often leads to silence instead of support.

Awareness and prevention efforts are expanding across the industry. Safety programs, trade organizations such as the [Associated General Contractors \(AGC\)](#), and mental health advocates are focused on creating jobsite cultures built on respect and open communication. Workers are encouraged to check in with each other, ask how coworkers are doing, and make it safe to speak up when someone is struggling.

Building a stronger construction industry means building one where mental health is treated as an essential part of overall safety and well-being. 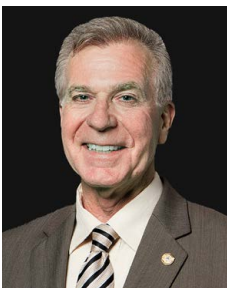

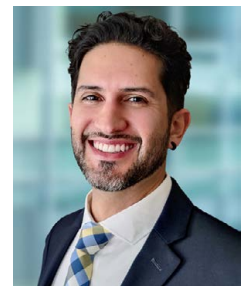

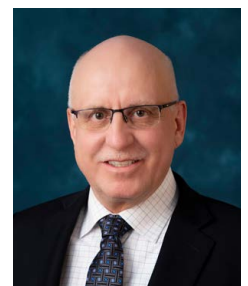

In Case You Missed It!

Highlights from CSLB's September Joint Meeting with the Nevada State Contractors Board and Quarterly Board Meeting

On September 5, 2025, the Contractors State License Board (CSLB) hosted a full day of discussions at headquarters in Sacramento, beginning with a joint meeting with the Nevada State Contractors Board (NSCB) followed by CSLB's regular quarterly board meeting. Both sessions focused on consumer protection efforts and licensing, enforcement, and public outreach opportunities and improvements.

JOINT CSLB/NSCB MEETING HIGHLIGHTS

During the joint session, both Boards shared updates on major projects and compared policy approaches across state lines.

TOPICS INCLUDED:

- **Brightline West High-Speed Rail Project Update:** Tom Roadcamp, Civil Engineer with Brightline West, presented an update on the high-speed rail line connecting Las Vegas and

Southern California. Construction began in 2024 and is expected to finish by 2028.

- **Surety Bonds Discussion:** Subject matter experts compared Nevada and California requirements for contract, court, and license bonds, outlining the history of surety, company ratings, and bond pricing. CSLB's bond increase from \$15,000 to \$25,000 in 2023 was highlighted as well as the study that led to the increase.

In addition to enforcement, CSLB provided cited individuals with information on how to become licensed and invited them to attend Get Licensed to Build workshops, which are part of CSLB's broader effort to bring more contractors into legal compliance.

WHAT DOES THIS MEAN FOR LICENSEES?

These enforcement operations are about more than just penalties. They are also about preserving the integrity of your profession. By holding unlicensed individuals accountable, CSLB helps ensure licensed

contractors can compete on a level playing field, backed by the standards and protections that come with having a license.

- **Licensing and Classification Reforms:** NSCB shared updates on the **B-7 Restricted License (SB 130)**, designed to expand entry-level opportunities, while CSLB discussed the success of the **B-2 Residential Remodeling License**, which has issued more than 1,200 licenses since 2022.
- **Solar Industry Updates:** CSLB reviewed complaint trends and the California Public Utilities Commission's Solar Disclosure Document, while NSCB presented Nevada's **SB 379**, establishing stricter consumer protections and contract standards for distributed generation systems.

The Boards reaffirmed their shared commitment to consumer protection, supporting licensees, consistent enforcement, and expanding cooperation on construction issues that cross state lines.

CSLB QUARTERLY BOARD MEETING HIGHLIGHTS

Following the joint session, CSLB convened its quarterly meeting to review division updates, legislative priorities, and ongoing strategic initiatives.

HIGHLIGHTS INCLUDED:

- **Registrar's Wildfire Response Update:** Registrar David Fogt provided an overview of CSLB's wildfire recovery initiatives: coordinating with affected communities, conducting enforcement operations to ensure licensed contractors are working in disaster zones, and offering consumer guidance for rebuilding safely.
- **Budget, Information Technology, and Administration Updates:** Staff presented CSLB's current fiscal position: revenue and

expenditure trends and the 2025–26 budget outlook. The Board was briefed on planned investments in technology to reduce paper-based workflows.

- **Legislative Updates:** The Board discussed recent and pending legislation, including CSLB-sponsored bills. More details about the bills that were signed and take effect in 2026 were previously highlighted in this issue.
- **Enforcement Update:** Highlights from recent investigations were shared including an ADU contractor collecting too much money upfront and performing little or no work along with a repeat offender being sentenced.
- **Licensing Division Update:** Licensing staff highlighted a record-breaking year for CSLB, with PSI administering more than 58,000 exams between August 2024 and July 2025. The Board also discussed changes made to CSLB's Spanish-language exams that have increased pass rates. A toggle feature now allows candidates taking the exam in Spanish to switch back and forth between Spanish and English to better understand questions.
- **Public Affairs & Outreach:** The Public Affairs team provided updates on digital engagement metrics and disaster response outreach efforts. The Board also got to see highlights of the video version of CSLB's Senior Scam Stopper seminar presentation, which can be found on [YouTube](#).
